To receive and consider the financial statements of the Company for the year ended 30 June 2018, consisting of the Financial Report, the Directors' Report and Auditor's Report.

#### **Resolution 1 - Remuneration Report**

To consider and, if thought fit, to pass the following resolution as an **ordinary resolution**:

#### **Resolution 2 - Re-Election of Robert Besley as a Director**

### **Explanatory Memorandum**

The Explanatory Memorandum accompanying this Notice of Annual General Meeting is incorporated in and comprises part of this Notice of Annual General Meeting and should be read in conjunction with this Notice of Annual General Meeting.

Shareholders are specifically referred to the Glossary in the Explanatory Memorandum which contains definitions of capitalised terms used both in this Notice of Annual General Meeting and the Explanatory Memorandum.

### **Voting Exclusion**

#### **Resolution 1**

A vote on Resolution 1 must not be cast (in any capacity) in favour of the resolution by or on behalf of any of the following persons:

- (a) a member of the Key Management Personnel, details of whose remuneration are included in the Remuneration Report; or
- (b) a Closely Related Party of such a member.

However, a person described above may cast a vote on Resolution 1 if:

- (c) the person does so as a proxy appointed by writing that specifies how the proxy is to vote on the proposed resolution; and
- (d) the vote is not cast on behalf of a person described in paragraphs (a) or (b) above.

If a shareholder wishes to nominate the Chairman as their proxy for the purpose of Resolution 1 the shareholder can direct the Chairman to vote by marking one of the boxes for Resolution 1 on the Proxy Form. If a shareholder appoints the Chairman as proxy or the Chairman of the meeting is appointed as proxy by default but the shareholder does not mark a voting box for Resolution 1, the shareholder will be taken to have expressly authorised the Chairman of the meeting to exercise the proxy in respect of Resolution 1 even though the item is connected with the remuneration of Key Management Personnel.

The Chairman intends to vote all available proxies in favour of Resolution 1.

#### **Resolution 3**

The Company will disregard any votes cast in favour of Resolution 3 if they are cast by or on behalf of T Bright or any associate of T Bright.

However, the Company need not disregard a vote if:

- (a) it is cast by a person as proxy for a person who is entitled to vote, in accordance with the directions on the relevant proxy form; or
- (b) it is cast by the person chairing the meeting as a proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

- (b) it is cast by the person chairing the meeting as a proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides.

### Resolution 5

The Company will disregard any votes cast in favour of Resolution 5 by:

- (a) A person who may participate in the proposed issue of shares and a person who might obtain a benefit, except a benefit solely in the capacity of a holder of shares, if the resolution is passed; and
- (b) Any associate of those persons.

However, the Company need not disregard any vote by any such persons on Resolution 7 if:

- (c) It is cast by any of them as proxy for a person who is entitled to vote, in accordance with the directions on the proxy form, or
- (d) It is cast by the person who is chairing the meeting as proxy for a person who is entitled to vote, in accordance with a direction on the proxy form to vote as the proxy decides

### Record date

The Company has determined, in accordance with regulation 7.11.37 of the *Corporations Regulations* 2001 (Cth), that the holders of Shares recorded in the Company's register as at 7pm (Sydney time) on 26 November 2018 shall, for the purposes of determining voting entitlements at the Annual General Meeting, be taken to be held by the persons registered as holding the Shares at that time.

### Proxies

## NOTICE OF ANNUAL GENERAL MEETING

This Explanatory Memorandum forms part of a Notice of Annual General Meeting convening the annual general meeting of shareholders of Silver City Minerals Limited (**Company**) to be held on 28 November 2018. This Explanatory Memorandum is to assist shareholders in understanding the background to and the legal and other implications of the Notice of Annual General Meeting and the reasons for the resolutions proposed. Both documents should be read in their entirety and in conjunction with each other.

The Directors recommend that shareholders read this Explanatory Memorandum in full before making any decision in relation to the resolutions.

Resolutions 1 to 4 are ordinary resolutions and Resolution 5 is a special resolution. They are separate resolutions and in no way dependent on each other.

### ORDINARY BUSINESS

#### 2018 Financial Report

This item of business relates to the receipt and adoption of the Company's Financial Report for the year ended 30 June 2018. The 2018 Annual Report can be accessed on the Company's website at [www.silvercityminerals.com.au](http://www.silvercityminerals.com.au).

#### Resolution 1 - Remuneration Report

The Remuneration Report is a section of the Directors Report contained in the 2018 Annual Report. It is a requirement of the Corporations Act that the Report be provided to shareholders and voted upon by a vote which is advisory only and does not bind the Directors or the Company. However, if 25% or more of the votes that are cast are voted against the adoption of the Remuneration Report at two consecutive AGM's, shareholders will be required to vote at the second of those AGM's on a resolution that another meeting be held within 90 days at which all of the Company's Directors who are subject to a re-election requirement must go up for re-election. At the 2017 AGM, 0.42% of votes were cast against approval of the Remuneration Report.

The Remuneration Report:

- Explains the Board's policies relating to remuneration of Directors, secretaries and executives of the Company;
- Discusses the relationship between such policies and the Company's performance;
- Provides details of any performance conditions attached to such remuneration; and
- Sets out remuneration details for each Director and certain named executives.

#### Resolution 2 - Re-Election of Robert Besley as a Director

Pursuant to clause 12.3(a) of the Company's Constitution, a Director must not hold office (without re-election) after

the third annual general meeting following the Director's appointment or three years, whichever is longer.

Mr Besley was re-elected as a Director at the 2015 Annual General Meeting of the Company and accordingly resigns and offers himself for re-election.

The Company provides the following information concerning Mr Besley:

#### Biographical details

Mr Besley is a geologist with more than 40 years' experience in the minerals industry in Asia, the Middle East, North and South America, Australia and the Pacific Rim. He spent 13 years with Unocal, seven of those as Manager of Minerals for Australia and the Pacific and was General Manager of Australmin Holdings Limited when that company developed a minerals sands project in eastern Australia and a gold mine in Western Australia. Mr Besley founded and was Managing Director of CBH Resources Limited from its initial ASX listing as a junior to when it was an important Australian zinc/lead/silver producer. He was a founding Director of Kimberley Metals Ltd, that became KBL Mining Limited. He is a Director and Chairman of the listed company Image Resources that is building a new mineral sands mine in Western Australia. He has served on a number of Government and Industry advisory boards.

#### Details of relationships between the Candidate and the Company

Mr Besley is the non-executive chairman of the Company.

#### Details of relationships between the Candidate and Directors of the Company

Not applicable.

#### Other directorships held

Mr Besley is a Director and Chairman of the listed company Image Resources NL.

#### The term of office already served by Mr Besley

Mr Besley joined the Board on 10 March 2010.

The Directors (other than Mr Besley) do not have an interest in the outcome of Resolution 2 and recommend that shareholders vote in favour of Resolution 2.

**Resolution 3 - Approval of Prior Issue of Shares on 20 September 2018**

A total of 370,370 Shares were issued on 20 September 2018 pursuant to Silver City's existing capacity to issue Shares under Listing Rule 7.1.

ASX Listing Rule 7.1 prohibits a listed company from issuing, or agreeing to issue, equity securities (which includes shares) that exceed 15% of the total number of fully paid ordinary securities on issue in any 12-month period, unless approval is obtained from the holders of the company's ordinary securities.

ASX Listing Rule 7.4 provides that an issue of securities made without approval under Listing Rule 7.1 will be treated as having been made with shareholder approval for the purposes of that Listing Rule if shareholders subsequently approve it and the issue did not breach Listing Rule 7.1.

If Shareholders approve Resolution 1, the issue of 370,370 Shares will be excluded from the calculations of the 15% limit under ASX Listing Rule 7.1.

In accordance with ASX Listing Rule 7.5 the following information is provided:

(a) A total of 370,370 ordinary fully paid shares were allotted on 20 September 2018 at a deemed issue price of \$0.027 per share.

(b) The securities were ordinary fully paid shares ranking equally in all respects with the Company's issued shares.

(c) The shares were issued to T Bright.

(d) The shares were issued as part compensation payable under an access agreement for drilling at the Company's Copper Blow Project.

A voting exclusion statement is included in this Notice.

The Board recommends Shareholders vote in favour of Resolution 3 as it allows the Company greater flexibility to issue further securities representing up to 15% under ASX Listing Rule 7.1. of the total number of Shares on issue in any 12-month period without Shareholder approval.

**Resolution 4 - Grant of Options to Managing Director, Christopher Torrey**

In accordance with Resolution 4 the Company proposes to grant 2,000,000 Options to the Managing Director, Christopher Torrey (or his nominee), as a component of his equity-based remuneration. The Options will be issued for nil consideration at an exercise price of 5 cents each with an expiry date being two years from the date of issue. The options will vest immediately.

Further terms and conditions of the Options are set out in the schedule to this Explanatory Memorandum.

Mr Torrey is a related party of the Company as he is a Director. The issue of Options constitutes a "financial benefit" as described in the Corporations Act.

Under Chapter 2E of the Corporations Act a public company cannot give a financial benefit to a related party unless an exception applies, or shareholders have, in a general meeting, approved the giving of that financial benefit to the related party. It is the view of the Board that the issue of Options to Mr Torrey, as a component of his equity-based remuneration, does not require shareholder approval under Chapter 2E of the Corporations Act and that the exemption in section 211(1) of the Corporations Act applies to the proposed issue of Options.

The Board considers that the issue of Options to Mr Torrey constitutes reasonable remuneration given the circumstances of the Company and the responsibilities involved in Mr Torrey's role as Managing Director. In this respect, the Board has specifically considered the number of Options proposed to be granted to Mr Torrey and the underlying value of those Options. Accordingly, the Company is not seeking shareholder approval under Chapter 2E of the Corporations Act for the issue of Options to Mr Torrey.

Shareholder approval for the grant of Options is being sought for the purposes of ASX Listing Rule 10.11. If shareholder approval is given under ASX Listing Rule 10.11, shareholder approval is not required under ASX Listing Rule 7.1.

If Resolution 4 is passed, it will permit the Company to issue the Options to Mr Torrey who is a Director, and therefore a related party of the Company.

**Valuation of Options**

The Option values have been calculated using a binomial option valuation model incorporating the terms of the options, the exercise price, the Company's share price of \$0.019 (being closing price prior to the date of this notice of meeting), the Company's expected share price volatility, and the risk-free interest rate. The valuation methodology calculated the average value of the Options at \$0.0026 per option with a total deemed value of \$5,200.

## EXPLANATORY MEMORANDUM

### *The maximum number of securities to be issued*

The Company will issue 2,000,000 Options to Mr Torrey (or his nominee).

### *The date by which the Company will issue the securities*

The Company intends to grant the Options to Mr Torrey as soon as practicable after the date of the Annual General Meeting but in any event, no later than one month after the date of the Meeting.

### *The issue price of the securities and a statement of the terms of the issue*

The Options will be issued for no consideration, with an exercise price of 5 cents each and an expiry date being two years from the date of issue. The options will vest immediately. The key terms of the Options are set out in the schedule to this Explanatory Memorandum.

### *Intended use of the funds raised*

No funds will be raised by the issue of the Options. Any funds raised by the exercise of the Options will be committed to the Company's working capital requirements

### **Directors' Recommendation**

The Directors (other than Mr Torrey because of his interest) recommend that shareholders vote in favour of resolution 4.

The Board (other than Mr Torrey) considers that the issue of 2,000,000 Options to Mr Torrey as part of his equity-based remuneration and in recognition of his contribution to the Company and his ongoing responsibilities is appropriate.

The Board has formed this view having regard to the nature of the role of the Managing Director and Christopher Torrey's level of skill and experience, and to the circumstances of the Company. Additionally, the issue of Options to Christopher Torrey allows him to further participate in the future growth and prosperity of the Company through share ownership, thus reinforcing his commitment to the Company.

### **Resolution 5 - Issue of Shares up to 10% of the Company's Issued Capital**

Listing Rule 7.1A enables an eligible entity to seek shareholder approval to issue Equity Securities up to 10% of its issued share capital over a 12-month period commencing from the Annual General Meeting where shareholder approval is received. The 10% issue capacity allowed under Listing Rule 7.1A ("7.1A 10% Capacity") is in addition to the Company's 15% annual placement capacity under Listing Rule 7.1.

An eligible entity for the purposes of Listing Rule 7.1A is an entity that is not included in the S&P/ASX 300

Index and has a market capitalisation of \$300 million or less. The Company is an eligible entity.

The Company is now seeking shareholder approval by way of a special resolution to have the ability to issue Equity Securities under the 7.1A 10% Capacity.

The exact number of Equity Securities to be issued under the 7.1A 10% Capacity will be determined in accordance with the formula prescribed in Listing Rule 7.1A.2.

Resolution 5 is a special resolution and therefore requires approval of 75% of the votes cast by Shareholders present and eligible to vote (in person, by proxy, by attorney or, in the case of a corporate Shareholder, by a corporate representative).

### **Listing Rule 7.1A**

#### Shareholder approval required

The ability to issue Equity Securities under Listing Rule 7.1A is subject to shareholder approval by way of special resolution at an Annual General Meeting.

#### Class of equity securities issued

Any Equity Securities issued under the 7.1A 10% Capacity must be in the same class as an existing quoted class of Equity Securities of the Company.

The Company, as at the date of the Notice, has on issue one quoted class of Equity Securities being fully paid ordinary Shares.

#### Calculating 7.1A 10% Capacity

Listing Rule 7.1A.2 provides that eligible entities which have obtained shareholder approval at an Annual General Meeting may issue or agree to issue during the period of the approval a number of Equity Securities calculated in accordance with the following formula:

$$(A \times D) - E$$

Where:

**A** is the number of fully paid Shares on issue 12 months before the date of issue or agreement to issue:

- **Plus** the number of fully paid Shares issued in the 12 months under an exception in Listing Rule 7.2;
- **Plus** the number of partly paid Shares that became fully paid in the 12 months;
- **Plus** the number of fully paid Shares issued in the
- 12 months with approval of holders of Shares under Listing Rule 7.1 and 7.4. This does not include an issue of fully paid shares under the entity's 15% placement capacity without shareholder approval;
- **Less** the number of fully paid Shares cancelled in the 12 months.

*Note that A has the same meaning in Listing Rule 7.1 when calculating an entity's 15% issue capacity.*

**D** is 10%.



**E** is the number of Equity Securities issued or agreed to be issued under Listing Rule 7.1A.2 in the 12 months before the date of the issue or agreement to issue that are not issued with the approval of shareholders under Listing Rule 7.1 or 7.4.

#### Effect of Listing Rule 7.1 with 7.1A

The ability of an entity to issue Equity Securities under Listing Rule 7.1A is in addition to the entity's 15% issue capacity under Listing Rule 7.1.

At the date of this Notice, the Company has on issue 246,210,253 Shares and therefore will have a capacity to issue:

- (i) Subject to approval of resolution 4, 36,931,537 Equity Securities under Listing Rule 7.1; and
- (ii) Subject to shareholder approval being sought under this Resolution 5, 24,621,025 Equity Securities under Listing Rule 7.1A

The actual number of Equity Securities that the Company will have capacity to issue under Listing Rule 7.1A will be calculated at the date of issue of the Equity Securities in accordance with the formula prescribed in Listing Rule 7.1A.2.

#### Minimum Issue Price

The issue price of Equity Securities issued under Listing Rule 7.1A must be not less than 75% of the VWAP of Equity Securities in the same class calculated over the 15 Trading Days on which trades in that class of Equity Securities were recorded immediately before:

- The date on which the price at which the Equity Securities are to be issued is agreed; or
- If the Equity Securities are not issued within 5 Trading Days of the date referred to above, the date on which the Equity Securities are issued.

#### Approval Validity Period

Shareholder approval of the 7.1A 10% Capacity under Listing Rule 7.1A is valid from the date of the Annual General Meeting at which the approval is obtained and expires on the earlier to occur of:

- The date that is 12 months after the date of the Annual General Meeting at which the approval is obtained; or
- The date of the approval by shareholders of a transaction under Listing Rules 11.1.2 (a significant change to the nature or scale of activities) or 11.2 (disposal of main undertaking).

#### **Specific Information required by Listing Rule 7.3A**

The Equity Securities will be issued at an issue price of not less than 75% of the VWAP for the Company's Equity Securities over the 15 Trading Days on which trading in that class of Equity Securities were recorded immediately before:

- (i) The date on which the price at which the Equity Securities are to be issued is agreed; or
- (ii) If the Equity Securities are not issued within 5 Trading Days of the date in paragraph (i) above, the date on which the Equity Securities are issued.

If Resolution 5 is approved by Shareholders and the Company issues Equity Securities under the 7.1A 10% Capacity, the existing Shareholders' voting power in the Company will be diluted as shown in the table below. There is a risk that:

- (i) The market price for the Company's Equity Securities may be significantly lower on the date of the issue of the Equity Securities than on the date of the Meeting; and
- (ii) The Equity Securities may be issued at a price that is at a discount to the market price for the Company's Equity Securities on the issue date or the Equity Securities are issued as part of consideration for the acquisition of a new asset, which may have an effect on the amount of funds raised by the issue of the Equity Securities.

The following table shows the dilution of existing Shareholders on the basis of the current market price of Shares and the current number of ordinary securities for variable 'A' calculated in accordance with the formula in Listing Rule 7.1A(2) as at the date of this Notice.

The table also shows:

- Two examples where variable 'A' has increased, by 50% and 100%. Variable 'A' is based on the number of ordinary securities the Company has on issue. The number of ordinary securities on issue may increase as a result of issues of ordinary securities that do not require Shareholder approval (for example, a pro rata entitlements issue or scrip issued under a takeover offer) or specific placements under Listing Rule 7.1 that are approved at a future Shareholders' meeting; and
- Two examples of where the issue price of ordinary securities has decreased by 50% and increased by 100% as against the current market price.

The table has been prepared on the following assumptions

- The Company issues the maximum number of Equity Securities available under the 7.1A 10% Capacity.
- No Options are exercised which have converted into Shares before the date of issue of the Equity Securities.
- Resolution 3 is approved.
- The 10% voting dilution reflects the aggregate percentage dilution against the issued share capital at the time of issue. This is why the voting dilution is shown in each example as 10%.
- The table does not show an example of dilution that may be caused to a particular shareholder by reason of placements under the 7.1A 10% Capacity, based on that Shareholder's holding at the date of the Meeting.
