### **Silver City Commences RAB Drilling on Zinc-rich Targets at Broken Hill**

- **New phase of exploration at Broken Hill.**
- **Work commences with rotary air blast (RAB) drilling on three projects.**
- **Approvals received for reverse circulation (RC) drilling at Stephens Trig and Razorback.**




Figure 1. Silver City tenements and projects at Broken Hill.

**Silver City Minerals Limited (ASX: SCI) (“Silver City” or “the Company”)** has commenced a RAB drilling program at Broken Hill. The work is designed to follow-up zinc (and lead-silver) targets outlined in earlier programs at Yalcowinna West and Razorback West. At Acacia Vale the work will test versatile time domain electromagnetic (VTEM) anomalies under alluvial cover (Figure 1).

Reverse circulation drilling at Stephens Trig is now planned to commence after completion of the RAB program. This will allow for more cost-efficient use of the RC drill rig should new drill targets be located in the RAB phase.

Environmental permits and land access arrangements are now in place for commencement of drilling at Stephens Trig and Razorback West.

#### **Background**

Previous exploration by the Company has outlined three projects where limited information suggests potential for near-surface zinc-lead-silver mineralisation hidden beneath a veneer of alluvial and soil cover. Targets are both geophysical and geochemical in character. This RAB program is designed to assess these with the view to outlining drill targets which might be tested at the same time as the upcoming Stephens Trig RC drilling.

A total of approximately 200 RAB holes are planned.
